

STEP-BY-STEP APPLICATION CHECKLIST FOR THE

RADIOLOGIC TECHNOLOGY STUDENT

- _____ Complete the MGCCC College Admission Requirements
- _____ Visit the Radiologic Technology Program Website page (located under Programs of Study/Health Sciences).
- _____ Review and Complete the **Mandatory** Pre-Health Sciences Orientation Session (*See website to access*)

Register for and successfully complete the following Prerequisites

- _____ Complete **at least 4** of the program's Academic Core courses. One of the 4 courses **must** be Anatomy & Physiology I. (Academic core courses include: MAT 1313 College Algebra, BIO 2514 Anatomy & Physiology, BIO 2524 Anatomy & Physiology II, ENG 1113 English Composition I, Social/Behavioral Science elective, Humanities/Fine Arts elective, and SPT 1113 Public Speaking.)
- _____ Achieve a GPA of 2.5 on College work with no grade less than "C" on any academic core courses.
- _____ Register for and successfully complete the HESI A2 Exam (Check Radiologic Technology website regarding Registration, Testing, Remediation, and Re-testing)
- _____ Achieve a minimum composite score of 18 or above on the ACT (Enhanced Version - Fall of 1989 or later). A score of less than 18 will not be accepted and cannot be waived.
- _____ Obtain a Criminal Background Check from a MGCCC Campus Police office. The CBC result is required prior to submitting the application. Please check the program's website for the Campus Police testing times.
- _____ **Prior to the deadline, but after successful completion of the above program entry requirements, submit the supplemental Radiologic Technology Application. (See website for steps on submitting the application). Contact an Enrollment Specialist at a campus of your choice for additional questions.**

Application Deadline: April 1st (Applications accepted beginning January 15th)
