- _____ Achieve a GPA of 2.5 on College work with no grade less than "C" on any academic core courses.
- Register for and successfully complete the HESI A2 Exam (Check Radiologic Technology website regarding Registration, Testing, Remediation, and Re-testing
- Achieve a minimum composite score of 18 or above on the ACT (Enhanced Version Fall of 1989 or later). A score of less than 18 will not be accepted and cannot be waived.
- Obtain a Criminal Background Check from a MGCCC Campus Police office. The CBC result is required prior to submitting the application. Please check the program's website for the Campus Police testing times.
 - Prior to the deadline, but after successful completion of the above program entry requirements, submit the supplemental Radiologic Technology Application. (See website for steps on submitting the application). Contact an Enrollment Specialist at a campus of your choice for additional questions.
