

# STEP-BY-STEP APPLICATION CHECKLIST FOR THE

- \_\_\_\_\_ Complete the MGCCC College Admission Requirements
- \_\_\_\_\_ Visit the Surgical Technology Program Website page (located under Programs of Study/Health Sciences).
- \_\_\_\_\_ Review and Complete the **Mandatory** Pre-Health Sciences Orientation Session (*See website to access*)

### **Register for and successfully complete the following Prerequisites**

- \_\_\_\_\_ Achieve a minimum Accuplacer English placement Score (Traditional Exam = 175; Next Generation Exam = 502)
- \_\_\_\_\_ Achieve a minimum Accuplacer Math placement Score (Traditional Exam = 53; Next Generation Exam = 231)
- \_\_\_\_\_ Hold a minimum Grade Point Average (GPA) of 2.0 on college work with no grade less than “C” on any General Education Core courses in the SUT curriculum
- \_\_\_\_\_ Hold a current American Heart Association CPR for Healthcare Providers certification
- \_\_\_\_\_ Obtain a Criminal Background Check from a MGCCC Campus Police office. The CBC result is required prior to submitting the application. Please check the program’s website for the Campus Police testing times.
- \_\_\_\_\_ Successfully **complete**, the following General Education courses.
  - BIO 2514 – Anatomy and Physiology I
  - BIO 2524 – Anatomy and Physiology II
  - ENG 1113 – English Composition I
  - MAT 1313 – College Algebra
- \_\_\_\_\_ **Prior to the deadline, but after successful completion of the above program entry requirements, submit the supplemental Surgical Technology Application. **Fall Application Deadline: July 1<sup>st</sup>** (Applications accepted beginning April 15<sup>th</sup>)

**Spring Application Deadline: November 1<sup>st</sup>** (Applications accepted beginning August 15<sup>th</sup>)

(If deadline falls on a weekend, holiday, or college closing, the deadline is 5 p.m. on the next college business day).
